BPA Council 2010 – nomination procedure

1. Proposed and seconded nominations **must** be received at the BPA Office by **no later than noon on Thursday 22 October 2009**. Nominations may be made either by completing and returning a paper copy of this form to the postal address / fax number above, or by e-mail to martin@bpa.org.uk **Proof of sending an e-mail or completed hard copy nomination form by post or fax cannot be accepted as proof of receipt, so please check to assure your nomination has been received.**
2. Nominations made by e-mail must include the following, and be sent from a recognised e-mail address of the Member (be it the nominee, proposer or seconder) for example as recorded on the BPA Membership database. If an e-mail is sent from a non-recognised or changed e-mail address, the sender must fax a signed paper copy to the BPA Office (fax 0116 247 7662) to authenticate its provenance.
 - 1 an e-mail from the nominee headed “**Council Nominee - [Nominee’s name]**” to include all the information from the nominee required below together with a **jpg image** of the nominee (head and shoulders). The nomination text may be included in the nominee’s e-mail with the agreement of the proposer and seconder, and/or the proposer and/or seconder may include the nomination text with their e-mails.
 - 2 an e-mail from the proposer proposing the nominee and his/her nomination text headed “**Proposer of [Nominee’s name]**”.
 - 3 an e-mail from the seconder seconding the nominee and his/her nomination text headed “**Seconder of [Nominee’s name]**”.
3. If a hard copy of this nomination form has been returned to the BPA Office by post or fax, a jpg image of the nominee (head and shoulders) should be e-mailed to martin@bpa.org.uk Sending hard copy passport-sized photographs is discouraged as the BPA Office does not have in-house facilities to convert them into the required jpg format.
